Subrogation & Recovery Process

Vaccaro and Associates will conduct a retrospective review of your claims for any missed subrogation opportunities as far back as 24 months, or within the statutory window designated by the claims jurisdiction.

Arbitration

While every effort is made to resolve a claim before going to arbitration, sometimes it cannot be avoided. When we encounter cases that we have been unable to settle within the examiner team but feel are good candidates for resolution through an arbitration venue, we then pursue arbitration.

Arbitration Forum, Inc. a non profit corporation, is a provider of intercompany arbitration services offering a means of settling claims without resorting to litigation. Vaccaro and Associates files arbitration cases through this forum.

Your Costs

Vaccaro and Associates does not charge an upfront fee or expenses to investigate subrogation opportunities. We charge only on a contingency fee basis, collecting only when the claim is settle and you have recovered your loss. We have negotiated a reduced fee for all National Limousine Association members. Our fee for all members is 19%.

SUBROGATION SERVICE AGREEMENT

This agreement, effective as of _____, is made and entered into by and between _____, the "Client" and Vaccaro and Associates.

WHEREAS, The client desires to engage Vaccaro and Associates to perform recovery services under the terms and conditions set forth below.

SUBROGATION SERVICES

Vaccaro and associates shall be given access to files belonging to the Client to review for potential recovery. Vaccaro and Associates will review all referred files and pursue subrogation in accordance with the terms of the agreement.

Vaccaro and Associates has reduced its fee for all National Limousine Association members to 19% in exchange for exclusive subrogation rights. Vaccaro and Associates shall have the authority to settle any referred file without prior approval of the Client for up to 50% of the total amount of the claim. Prior approval will be required to settle all claims for less than 50% of the claim.

For its work, Vaccaro and Associates shall be paid a contingency fee of 19% of the recovered amount. Recoveries shall be remitted to the Client at the time of payment. Vaccaro and Associates does not charge for out-of-pocket expenses incurred in the investigation and development of the file for subrogation.

Vaccaro and Associates will provide Client with a detailed accounting of its recovery displayed on a report form to include placement date, Client Name, Insured name, claim number, settlement amount, Vaccaro and Associates fee and net benefit to Client.

TERMINATION

This agreement may be terminated by either party without cause at any time by giving the other party advance notice of termination of at least 30 days. Such notice shall be in writing and delivered to either party.

CONFIDENTIALITY

The parties agree to maintain all Confidential information in confidence, not to use the Confidential information for any purpose other than for the purpose of its business with the disclosing party and to only disclose to each other's respective officers or managers. Confidential information includes information in oral form, written form, electronic form, and/or contained in any other type of storage medium.
